

Tour Charlotte Sweepstakes Official Rules:

HOW TO ENTER:

1) Go online to www.Charlottesgotalot.com/TourismSweepstakes, complete the online entry form and submit it in accordance with the on-screen directions during the sweepstakes period. All fields are mandatory to be entered; incomplete entries are not considered valid. **Limit of one entry per person via any method of entry.** All entries must be received by 5:00 p.m. (EST) August 31, 2010. No entries using any automated quick-entry program permitted.

All entries submitted become the sole property of Visit Charlotte.

ELIGIBILITY:

To enter the Sweepstakes, you must, at the time of entry, be a lawful, permanent resident of the 48 contiguous United States or the District of Columbia, be 18 years of age or older, and be physically located in the 48 contiguous United States or the District of Columbia.
